The Direct Debit Guarantee

- This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits
- If there are any changes to the amount, date or frequency of your Direct Debit The University of Hertfordshire Charitable Trust will notify you 10 working days in advance of your account being debited or as otherwise agreed. If you request The University of Hertfordshire Charitable Trust to collect a payment,

confirmation of the amount and date will be given to you at the time of the request

- If an error is made in the payment of your Direct Debit, by The University of Hertfordshire Charitable Trust or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society
- If you receive a refund you are not entitled to, you must pay it back when The University of Hertfordshire Charitable Trust asks you to
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.



Notes on the Gift Aid Scheme

- If your declaration covers donations you make in the future, please notify The University of Hertfordshire if you change your name or address while the declaration is still in force.
- You can cancel the declaration at any time by notifying The University of Hertfordshire Development Office – it will then not apply to donations you make on or after the date of cancellation or such later date as you specify.
- You must pay an amount of income tax and/or capital gains tax at least equal to the tax that the charity reclaims on your donations in the tax year (currently 25p for each £1 you give).

- If in future your circumstances change and you no longer pay tax on your income and capital gains equal to that tax that the charity reclaims, you can cancel your declaration (see note 1).
- 5. If you pay tax at the higher rate you can claim further tax relief in your Self Assessment tax return.
- If you are unsure whether your donations qualify for the Gift Aid tax relief, ask the Development Office on 01707 281310.
