

Independent (Estranged) Student Bursary – Terms and Conditions

Bursary details

- 1. The Independent (Estranged) Student Bursary is a payment of £1,800 per year for undergraduate students aged 18-24 with a 'Home' fee status who have confirmed independent student status due to estrangement.
- 2. At the University of Hertfordshire, we use Stand Alone's definition of an independent (estranged) student. This states that an independent student is "someone who has not had verbal or written contact with both of your biological, adoptive parents or your only living parent for a significant period of time and this will not change". A 'significant period of time' is usually considered twelve (12) months or longer prior, although periods of less than twelve (12) months will be considered in some circumstances.
- 3. Independent student status due to estrangement is confirmed through Student Finance England (or relevant awarding body) via the University of Hertfordshire's 'Student Finance' team.
- 4. Bursary funds are provided to help with the additional costs associated with studying full-time including food, travel, bills, and study materials.

Eligibility

- 5. To be eligible for the bursary, students must be:
 - a) under the age of 25 on the first day of the academic semester in which they start their programme of study, according to the dates published in the University of Hertfordshire's published academic calendar;
 - b) registered on a full-time University of Hertfordshire undergraduate course delivered directly by the University of Hertfordshire or one of its consortium colleges
 - c) actively studying (i.e. not in a period of dormancy or suspension of studies).
 - d) a 'Home' fee paying student as assessed by the University of Hertfordshire (<u>findout more about your fee status here</u>);
 - e) receiving the maximum Maintenance Loan as assessed by the Student Loans Company; and
 - f) studying their first degree.
- 6. Students must have confirmed independent student status due to estrangement through Student Finance England (<u>find out more about how independent student status is assessed here</u>). When a student is 25 or over, Student Finance England will no longer confer estranged status. For these students, an assessment of status (with supporting evidence) will be undertaken by the University of Hertfordshire's 'Widening Access and Student Success' team to determine the student's eligibility for the bursary.
- 7. Students must be registered on a full-time course studying a minimum of 120 credits per academic year to receive the full £1,800 bursary. If they are studying above 30 credits and below 120, they will receive £1,200 (in three (3) instalments of £400). If they are studying fewer than 30 credits, they will not be eligible for the bursary.

- 8. Students will not be eligible if they are:
 - a) studying an initial or foundation year prior to their undergraduate degree. They
 will be eligible for the bursary (subject to the above conditions) once they have
 completed their initial year or year zero programme and have progressed to year
 one of their undergraduate degree;
 - b) studying a distance learning course/programme;
 - c) undertaking a degree apprenticeship; or
 - d) studying part-time.

Application process

- 9. Students will need to provide evidence of being independent due to estrangement. In the first year of application, when students are under the age of 25, this must be in the form of a confirmation letter or email from Student Finance England, e.g. Student Finance England Notification of Entitlement letter.
- 10. For every subsequent year, students will need to provide evidence of their ongoing estranged status. For students under 25, this must be in the form of a confirmation letter or email from Student Finance England. For those who are over 25, an assessment of estranged status (with supporting evidence) will be undertaken by the University of Hertfordshire's 'Widening Access and Student Success' team.
- 11. Students should provide the above evidence by email to <u>independent-estranged</u> <u>@herts.ac.uk</u>, along with their name, programme of study, student ID number, and contact details.
- 12. All students who meet the eligibility criteria and provide the evidence detailed above will be considered for the bursary. All applications will be considered on an individual basis and awarded subject to the availability of funding.

Payment

- 13. The bursary will typically be paid in three (3) instalments of £600 in each year of an undergraduate degree programme. For students starting their course in September and with confirmed independent student status due to estrangement at this point, this will typically be:
 - a) 1st payment October
 - b) 2nd payment February
 - c) 3rd payment April
- 14. The payment date and bursary amount may vary depending on when a student has received confirmation of their status:
 - a) If a student receives their confirmed status between September and December, or has status for the duration of their studies, they will receive the full bursary of £1,800 in three instalments as outlined above.
 - b) If a student receives their confirmed status between January and March, they will receive the second and third instalments only. Therefore, a total of £1,200 will be received.
 - c) If a student receives their confirmed status in April, they will receive only the third instalment of £600.
 - d) If a student receives their confirmed status after April, they will not be eligible for the bursary during that academic cycle. However, discretionary financial support may be provided on a case-by-case basis.

- 15. Returning students who received the bursary in the previous academic year will be contacted in September to confirm their ongoing eligibility and to ask them to update their bank details. Students who are no longer eligible (for example if they were granted independent student status by estrangement for the previous academic year only) will be informed of the process for re-confirming their independent student status through Student Finance England. For students who are over 25, an assessment of status (with supporting evidence) will be undertaken by the University of Hertfordshire's 'Widening Access and Student Success' team.
- 16. Other students who have self-identified as independent but do not yet have confirmed independent status through Student Finance England will also be contacted and informed of the process for confirming their status.
- 17. Students are responsible for ensuring the bank details they provide to the University of Hertfordshire are correct. Incorrect bank details may cause delays in payment.
- 18. Bursary payments cannot be claimed retrospectively for previous academic years.
- 19. Payment in subsequent years will only be made if the student progresses to the next level of study.
- 20. Students will be able to receive an award for the duration of their undergraduate course, usually for a maximum of three (3) years.
- 21. An extra year of funding may be provided to cover exceptional circumstances, such as a repeat year. Any such additional funding will be at the discretion of the University of Hertfordshire and subject to availability of funds.

Change of circumstances

- 22. **Mode of study:** Students who change mode of study from full-time to part-time or to distance learning will no longer be eligible for the bursary.
- 23. **Dormancy:** Students who take a period of dormancy (a voluntary suspension of studies) and are in receipt of the bursary; will not receive any further payments whilst dormant.
- 24. **Placements or study abroad:** Students will continue to receive the bursary if they undertake a placement or study abroad as part of their degree subject to confirmation by the programme lead or equivalent that the student is undertaking a placement or study abroad as part of their degree programme.
- 25. **Withdrawal from study:** Students who withdraw from their programme at any stage prior to completion will no longer be eligible for the bursary.
- 26. **Suspension of study:** Bursary payments will not be paid during any period of suspension. Reinstatement of payments will be dependent on the student returning to active study status. Students will not receive any payments that were withheld during the period of suspension.
- 27. **Transfer of course**: Students who transfer to a different programme of study will continue to receive the bursary for the duration of their undergraduate degree up to a maximum of four (4) years. For example, a student who completes Year 1 of a degree programme and then transfers to a different programme, will receive the bursary for a

maximum of a further three (3) years. A student who completes Year 1 and Year 2 of a programme and then transfers would be eligible to receive the bursary for a further two (2) years.

Return of funds

28. The University of Hertfordshire reserves the right to seek a full or partial return of funds if a student within a short time of receiving a payment discontinues their studies, is withdrawn, or goes dormant. This will typically apply for discontinuation/withdrawal/dormancy that takes place within four (4) weeks of payment being issued. The decision as to whether a partial or full repayment is required in these circumstances, will be decided on a case-by-case basis by the University of Hertfordshire's 'Widening Access and Student Success' team.

Other bursaries

- 29. Students cannot be considered for the Care Leaver Bursary, the Displaced Learners Bursary, or the Young Adult Carers Bursary, if they are eligible for the Independent (Estranged) Student Bursary.
- 30. Students cannot be considered for the UH Bursary if they receive the Independent (Estranged) Student Bursary. However, if a student qualifies for the Independent (Estranged) Student Bursary after having received the UH Bursary, they will be transferred to the bursary of greater value and payments will be adjusted accordingly.
- 31. Students awarded the Independent (Estranged) Student Bursary may also be eligible to apply for University of Hertfordshire scholarships¹.

Complaints

32. Complaints will be dealt with according to the University of Hertfordshire's complaints procedure. In the first stage informal complaints should be made to the University of Hertfordshire's 'Widening Access and Student Success' team via studentsuccess@herts.ac.uk. Every reasonable effort will be made to respond to the issue raised and reach an informal resolution. If a resolution is not reached at this stage, a formal complaint can be made using the process detailed in the University of Hertfordshire's complaints procedure.

¹Bursaries usually refer to a one off annual or termly payment, to help with living costs, awarded on the basis of student background or personal circumstances. Scholarships can be either to support with living costs or to cover tuition fees and are usually awarded via application on the basis of achievement.
