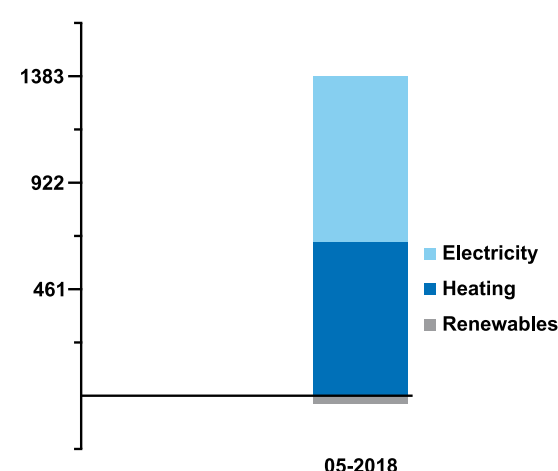

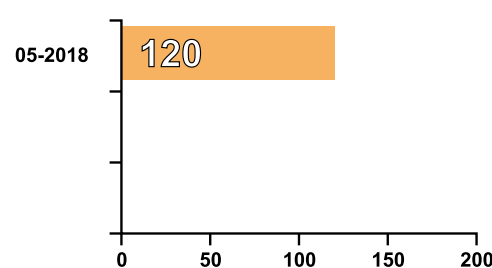
Total CO₂ Emissions
